


1/2" to 4" Dual Gauge Port Ball Valves

Elements

- For control of most common medical gases, including nitrogen and vacuum
- Includes copper extensions and dual gauge ports
- Full port flow-through design reduces gas flow restrictions
- Cleaned for oxygen service per CGA G-4.1
- Durable seals for longer, trouble-free life
- Blow-out proof stem



Description

All ball valves are factory cleaned for oxygen service, individually bagged, and conform to NFPA 99 standards. Each 1/2" to 4" valve consists of Teflon seats and adjustable stem packing gland with a Teflon stem seal.

1/2" to 2-1/2" valves are rated at 600 psig. 3" and 4" valves are rated at 400 psig. All valves are rated for full vacuum (29.9" Hg). Valves go from full ON to full OFF by turning the vinyl-gripped valve handle 90°. Latching handles are standard. Type K copper tubing is factory installed to help prevent valve seat damage during brazing. Each valve shall have two gauge ports.


Materials

- Body Bronze
- End plates Bronze
- Ball for 1/2" to 2-1/2" ball valve Chrome-plated brass
- Ball for 3" to 4" ball valve Grade 316 stainless steel
- Stem for 1/2" to 2-1/2" ball valve Brass
- Stem for 3" to 4" ball valve Grade 316 stainless steel
- Handle for up to 2-1/2" ball valve Plated steel with vinyl grip
- Seats/Packing/Stem Seal for ball valve up to 4" Reinforced Teflon
- Tube Extension Type K copper






Lockable Handles

All ball valves are delivered fitted with either a lockable handle or a collar, as required for in-line installation by NFPA 99. 1/2" to 2-1/2" valves are equipped with a lockable handle. 3" and 4" valves are equipped with a lockable collar.
